If there is no trainer, the owner/agent must sign both lines. The person who signs as trainer must be 18 or over. Parent/guardian signature is required on entry forms for juniors, or if not available, the trainer must sign on the minor's behalf. (See definition of trainers and coaches in general rules) **By signing and submitting an entry to this show, it is your intent to show and agree to our rules. You agree to pay all fees due and understand that refunds will not be made. Please contact the show secretary for clarification if you have any questions regarding entry policies.**

- You may pay by bank check or money order. Make checks payable in US Funds to THE CASCADE. **Checks must be received by April 25.** Open checks are not allowed for the initial entry. If an open check is sent, it will be closed for the amount due at the time the entry is processed and deposited. Postdated checks will not be accepted. Secretary reserves the right to finalize open checks. Delayed checks will incur a Late Entry penalty.
- **At the show** all exhibitors will be required to leave an open check, separate from their entries at check-in, before show numbers will be released, to cover any additions or penalties incurred at the show.

## CANCELLATIONS AND REFUNDS

- To encourage early entries, Management agrees to cancel and refund entry and stall fees on any horse not fit to show providing written notice is given to the Show Secretary on or before the entry closing date of **April 20, 2023**
- Refunds will be considered for any horse suffering from illness or injury upon the presentation of a veterinarian's certificate, or any exhibitor suffering from illness or injury upon the presentation of a doctor's letter to the Show Secretary PRIOR to **7pm Wednesday, May 10, 2023**, and will be subject to the Management's decision.
- All other requests for refunds will be made in writing and submitted to Management for consideration.
- On approved refunds, such refund will include all fees less a \$25 cancellation fee.
- Substitution of horses will be permitted in accordance with USEF GR910.
- Horses may be scratched from a class or the entire show at the exhibitor's option but will not be entitled to a refund.

**ENGLISH AND WESTERN DRESSAGE INFORMATION**

**Dressage times are limited!** Entries open at 0001 April 5 and close April 20 at midnight. If sent before the open date, a 48-hour penalty will apply. Entries received after closing date are not guaranteed accommodation. Classes may not be scheduled in this order. Order of go will be assigned, emailed and posted in the Show office. Intro and Training/Basic Level classes may be held in the short arena (60m x 40m); court size posted with ride times. In order to accommodate all those who wish to ride, some English Intro and/or Training Level dressage tests may be scheduled on Saturday after Western dressage with Mrs. Trentelman or a different judge. Training devices will not be allowed in the designated dressage area at any time or in any other warm-up areas when warming up for Dressage. Entries will be accepted in the order received and when time is filled, a waiting list will be started.

2022 Western Dressage and 2023 USEF, USDF Tests will be used. Western Dressage ties, if any, will be broken in accordance with USEF AR235. English Dressage ties will be broken in accordance with DR 123 and if still tied, AR174.

**Admission to the arena**• No person may enter the space set aside for the judging or hold any communication with the judge without permission of the steward or show manager, who will arrange an appointment with the judge at the proper place and time. Failure to comply with this request could result in disqualification from subsequent classes and forfeiture of all entries, prize money, trophies and ribbons. All attendants must be neatly and properly dressed. Special attention should be given to dress and demeanor on entering the ring.

**Age of Horse and Rider**• For horse show purposes any horse shall be considered to be 1 year old on the first day of January following the actual foaling date. Junior exhibitors are those who have not reached their 19th birthday by 12/1/2022. Junior exhibitors are considered amateurs and do not need amateur certification. **Horses entered in Dressage classes must be 36 months old.**

**Amateur Owner "Family" Definition**• Horses entered in amateur owner and junior owner classes must be registered in the name of the competitor or a member of the competitor's family, as defined by USEF rules. (Horses registered in a farm, ranch, syndicate, partnership, corporation name may be shown in Amateur Owner classes provided the family is the sole owner of the farm or entity as defined by USEF rules). The sale of a horse does not eliminate this registration requirement. Contracts of Sale or Bill of Sale will not be accepted for owner classes.

**Awards**• First Place Award and ribbons to 6th in each class. Junior Exhibitor Performance and Equitation will have ribbons to eight places.

**In-Hand**• The AHA Score sheet will be used for Sport Horse In-Hand.

**Change of Handler/Rider**• It is the obligation of the exhibitor to notify the show office of any change in rider, driver, handler or cancellation of entry and exhibitors must fill out a handler/rider change form with correct association numbers and documentation in the show office **prior to their class**. This also applies to **equitation horses** changed after entry has been processed. Changes must be submitted before the end of the session before the class is held.

**Changes to schedule or venue**• Management reserves the right to make changes of arenas, judges or class order to facilitate time schedule and conditions. All changes will be posted on the announcement board at the office and the appropriate announcements made during the competition. Classes with no entries by closing date may be cancelled. Competition management reserves the right to cancel, combine or split classes at its discretion. Show management reserves the right to add or substitute judges as required. Upon receipt of the preliminary ride schedule, it is the rider's responsibility to notify Show Management if they are NOT eligible to show for a substitute or added judge.

**Class Conflicts**• Exhibitors are cautioned against entering the same horse or rider in successive classes. Due to a very full schedule, we will not hold the gate beyond the normal gate hold allowed. No refunds will be given for missed classes or conflicts.

**Cruelty**• The abuse of a horse by any person is forbidden, constitutes a violation under Chapter 7, and renders the offender subject to penalty. The following acts are included under the words Cruelty and Abuse but are not limited thereto - Use of shackles, hock hobbles and similar devices (not to be construed as rubber or elastic exercising devices) Excessive use of a whip on any horse, in a stall, runway, schooling area, show ring, or elsewhere on the show grounds before or during a show, by any person. Attention getting devices &/or other noisemakers (including but not limited to tape measures, blow horns, altered bamboo poles, laser pointers, explosives, etc.) are not allowed.

**Discipline**• Exhibitors are warned that any act of discourtesy or disobedience to the officials on the part of the owner, trainer, groom or rider will disqualify the horse from adjudication. The show committee reserves the right to remove a horse, owner, rider or groom from the show without being liable for compensation or damages. It is a violation of USEF rules to commit any act or make remarks during the show that are considered offensive or made with the intent to influence or cast aspersions on the judging, and any exhibitor may be barred from the show for this offense.

## ATTENTION COMPETITORS

Each competitor is responsible for supplying management with correct applicable numbers (AHA, USDF, USEF & WDAA) for horse, owner, riders, handlers, and trainer, before the day(s) of the competition.

The scores of competitors who fail to supply correct numbers may not be counted toward national awards.



**Disposal of Needles & Medical Waste**• Any owner, trainer, exhibitor or their agents, who improperly dispose of needles or other sharp disposable instruments, will be fined \$300 by the competition management.

**Dispute Not Covered by Rules**• Should any question or dispute arise not provided for in the governing rules, the same shall be referred to the Executive Show Committee whose decision shall be final.

**Headgear • (GR801)** Except as may otherwise be mandated by local law, the Federation strongly encourages all riders, while riding anywhere on the competition grounds, to wear protective headgear with harness secured which passes or surpasses ASTM/SEI standards for equestrian use and carries the SEI tag. (Exception hunter, jumper, or hunter/jumper competitions refer to GR801.2) It is the responsibility of the rider, or the parent or guardian or trainer of the junior exhibitor to see to it that the headgear worn complies with appropriate safety standards for protective headgear intended for equestrian use, and is properly fitted and in good condition, and the Federation, Show Committee, Competition Management, and Licensed Officials are not responsible for checking headgear worn for such compliance.

**Important information for all Dressage exhibitors:** USEF Rule DR120.1.1: Helmets are required for all riders as noted in the following USEF rule From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, mounted participants in exhibition classes and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place.

**Judging Assignment**• Single judge system will be used for all classes. Management reserves the right to make changes of judges to facilitate time schedule and conditions.

**Leased Horses**• may not be shown by the lessee in Amateur Owner To Ride (AOTR) classes. The lessee becomes the bona fide owner of the horse for the period of the lease (except for Owner classes) for Federation award purposes. The horse must be entered in the ownership of the lessee and must be shown in accordance with USEF Chapter 11.

**Post Entries**• will be closed after the last class of the session before the class is held. Dressage, Western Dressage & In-Hand post entries are only allowed in the event a ride/run time becomes available. Horses entered prior to the closing date will pay a \$5 post entry “add” per class. Horses entered after the closing date will pay a flat \$20 Late Entry Fee.

**Protests** must be filed as set forth in USEF rules.

**Responsibility**• Region 5 AHA will not be responsible for any loss, damage or injury to horses exhibited or for any article of any kind or nature that may be lost or destroyed or in any way injured. Each exhibitor will be responsible for any injury that may be occasioned by any person, whomsoever, by any horse owned or exhibited by him, and shall indemnify the occasioned by any horse owned or exhibited by him or arise from the negligence of the person in charge of such horse. All horses will be exhibited in this show entirely at the owner’s risk.

**Refunds** • Entry fees will not be refunded in the event that all or part of the competition is cancelled due to a storm, acts of God, illness, accident, or other emergency at the show. Refunds for improperly entered classes only in cases of secretary error.

**Refusal of Entries**• The Region 5 AHA Board of Directors has directed that entries must be refused from anyone that has an outstanding obligation to **any** Region 5 affiliated club, show or contracted services. Management reserves the right to hold classes conditionally, or cancel entries of any contestant, as stated in USEF Rules. Show management reserves the right to reject any entry if it seems to be in the best interest of the show. The show committee reserves the right to remove any owner, groom, rider, trainer, manager, coach or driver groom (header), horse or rider from the show who has shown an objectionable attitude or behavior towards its management, or previous unsportsmanlike behavior, without being liable for compensation or damages.

**Returned Checks**• Checks returned by the bank for any reason will incur a \$75 charge per domestic check (\$100 per international check). Payments will not be processed through the bank a second time. Show packets will not be released until all debts are settled. In the event a check is returned after the completion of the show, it will be handled in accordance with USEF rules.

**Ride times**• will be posted at [www.regionv.com](http://www.regionv.com). Show staff will not follow up with exhibitors who request ride times to be e-mailed but do not provide **a legible e-mail address**. Announcements will NOT be made. Exhibitors are responsible for being ready to enter the arena at their assigned ride times. Exhibitors that arrive late will not get to ride and will not receive a refund.

**Score Sheets**• If a mathematical scoring error on the score sheet is discovered, it must be reported to Show Secretary within one hour of the official posting of the scores from the last scored class of that competition day or the error will stand with no change in class placings. Please claim all Dressage test sheets and In-Hand score sheets at the awards room before you leave the show; they will not be mailed.

**Scratches and ‘no shows.’** If you don’t show up for an assigned dressage ride time, this competition reserves the right to scratch you from all remaining dressage rides and offer them to other exhibitors.

# FACILITY GUIDELINES

**Arenas** • Arena footing in all arenas is sandy loam. The Indoor arena is 100 x 220, an outdoor 150' x 250', an outdoor 120' x 180' and a 60' round pen. Unless otherwise announced, arenas will be groomed before the first class of each session.

**Call for Classes.** It is the exhibitors' responsibility to follow how quickly classes are progressing and to promptly present themselves when the gate person calls for their class. The public address system is considered a courtesy to the exhibitors and its function or coverage of areas cannot be guaranteed. No refunds will be made solely because of sound system inadequacy or failure.

**Common Areas** • The facility's Rehabilitation Center and paddocks are not available to us.

**Electrical** • Extension cords and power strips will be useful for tack/ready stalls.

**Food** • There will be food available on the grounds in the mornings and afternoons from local food vendors.

**Horse Wash Area** • There are uncovered, cold water wash racks at the end of the stall rows.

**Lungeing** • Areas will be posted in the office.

**Pets** • Dogs (and Cats) are not permitted to be loose on competition grounds and **must be on a leash or otherwise contained**. Individuals must not lead dogs on a leash while mounted. Pets are not allowed in the arenas at any time. Please do not leave pets unattended in stalls. Pet owners are solely responsible for any damages, claims, losses or actions resulting from their pet behaviors.

**Manure disposal** • Bunkers are available at the end of each stall row. Please use them.

**Motorized Vehicles** • Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible

for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. (01/19/2022)

**No Smoking** • There is **NO SMOKING** in the buildings, barns, arenas or bleachers.

**Stabling** • Stalls are 10 x 10 portables with full doors and are not matted. Stalls are available from Thursday 12 NOON through Sunday 6:00 PM Those exhibitors requiring stabling outside of these parameters must make arrangements with the show secretary. Stabling is available only for horses entered in the competition with a liability release on file with the show secretary.

**Travel Requirements** • You are responsible for being in compliance with Washington transport requirements.

**Vaccination Policy** • Exhibitors are reminded of USEF's vaccination policy, effective 12/1/15; see GR844 for details. Download the form:

<https://www.usef.org/documents/membership/EquineVaccinationRecord.pdf> Bring the completed form, signed by your veterinarian, with you to the competition. Competition Management reserves the right to review vaccination documentation. Non-compliant entries may be quarantined or denied permission to unload and will not be allowed to compete nor to mingle with other horses. No refunds will be given if right to compete is denied because the Vaccination Record is missing or incomplete. Please maintain high standards of hygiene in all areas where horses reside or interact with handlers. **Info on disease outbreak and biosecurity is available at <https://equinediseasecc.org/>.**

## THIS IS A USEF "LOCAL" MEMBER SHOW



### USEF MEMBERSHIP REQUIREMENTS FOR PARTICIPATION IN AMATEUR RESTRICTED CLASSES

Equine Canada members who are not current USEF members and want to compete in an amateur class are not required to pay for a USEF membership or Show Pass fee; however, they must fill out the USEF membership application with their name, signature, date of birth and check the "Amateur" box in order to be eligible to compete in an amateur restricted class.

**ANYONE ELSE COMPETING IN AN AMATEUR CLASS WILL BE REQUIRED TO SHOW PROOF OF AMATEUR STATUS ISSUED BY USEF.** Only active Federation members [Competition memberships] may obtain amateur status. Every person who has reached his/her 19th birthday and competes in classes for amateurs under Federation Arabian rules must possess current amateur status issued by the Federation. Exceptions • Any person who has not reached his/her 19th birthday as of December 1 of the previous calendar year is a Junior Exhibitor; all Junior Exhibitors are considered amateurs for competition purposes. Proof of amateur status is not required for Opportunity classes.

**REMINDER: US EQUESTRIAN SAFE SPORT** -All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. ### USEF MEMBERSHIP STATEMENT

Eventing Competitions at the Modified Level or above, Combined Driving Competitions at the Advanced Level, Dressage Competitions, Endurance Rides and Vaulting Competitions: (See GR828.4 of the Federation rules). Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent, at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) headline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR231) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

### AHA MEMBERSHIP STATEMENT

Each competitor (this includes at least one recorded owner and all trainers, drivers, riders, halter handlers, coaches and the person(s) signing the entry blank) in an Arabian Horse Association recognized Arabian division, at the time of entry into a competition, must submit a valid AHA Membership /Competition number on the entry form, join AHA or pay an AHA Single Event Membership Fee per competitor. When an Agent signs for the Owner at an AHA recognized competition, both the Owner and Agent must be members of AHA or pay the AHA Single Event Membership. Single Event Membership is not acceptable at AHA Regional or National Competitions. Exhibitors in walk-trot classes are exempt from AHA membership requirements at qualifying competitions but must have an AHA membership with Competition Card at AHA Regional and National Competitions. Exhibitors in headline classes or parents/ guardians signing for minors are exempt from AHA membership requirements.



**AHA Competition Card Requirements.** Current COMPETITION membership numbers for all concerned must be on the entry or entry will be considered incomplete. All riders, drivers, owners, agents and handlers who exhibit horses in the show ring or sign the entry form as the responsible party for any individual's horses at the show must show proof of AHA COMPETITION level membership or pay a Single Event Membership fee of \$35 per person. If the recorded owner is an entity (Farm, Ranch, Syndicate, etc.) and does not have a current AHA Business membership, a Single Event Membership must be purchased for that entity. Exhibitors in Walk/Trot classes and Parents/Guardians signing for minors are exempt from AHA membership (refer to AHA Article 705).

### WDAA MEMBERSHIP



To be eligible to participate and/or compete as an exhibitor, owner, lessee, agent, coach, or trainer in any Western Dressage class or at any Western Dressage Federation Licensed Competition persons must be active members of WDAA ([westerndressageassociation.org](http://westerndressageassociation.org)) or pay a non-member fee equal to the price of an annual membership for each competition. Lessees are considered owners in connection with this membership requirement. In the event of an entry under multiple ownership, only one owner need be a Member or pay a non-member fee. The competition is responsible for listing either the active member or the owner that paid the non-member fee in the results. The competitions will be responsible for forwarding a list of the names of individuals who pay non-member fees at the competition to WDAA with the post competition report. Payment of non-member fees for the purpose of competing does not entitle the individual to any privileges of the WDAA membership.

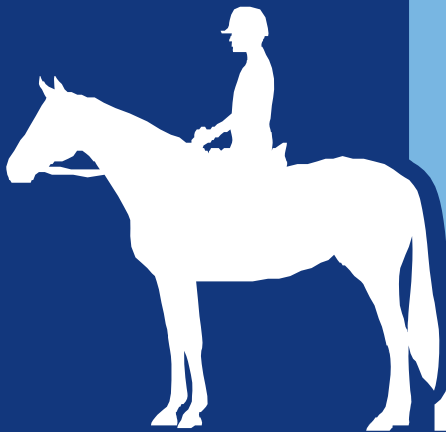

# UNITED STATES DRESSAGE FEDERATION

**USDF Membership Benefits:** USDF is dedicated to education, the recognition of achievement, and promotion of dressage. For details on member benefits, including educational programs, awards, and other opportunities, refer to the *USDF Member Guide* or the USDF website at [www.usdf.org](http://www.usdf.org).

**Membership Requirements for USEF-licensed/USDF-recognized Competitions:** Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

## Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

## Memberships Defined

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

**AHA ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION This document waives very important legal rights. Read it carefully before signing.**

In consideration for AHA permitting me to participate in this Competition, and by signing the entry blank, I agree as follows:
I AGREE that I choose to participate voluntarily in this Competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.
I AGREE as a Horse Show Participant (or Parent/Guardian of Participant if a minor) to waive all claims which may otherwise arise from, including but not limited to infectious bacteria, viruses, fungi/mold, parasites or other agents which may be present at the Horse Show (and most other outdoor locations) and can cause infection in humans, as well as in animals.

I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.
By signing below as a parent or guardian of a junior exhibitor, I consent to the child's participation and agree to all of the above provisions, and further agree to assume all of the obligations of this AHA Assumption of Risk, Release and Indemnification personally and on behalf of the child.
